Under the general supervision of the Assistant Director, Translation Services within the Communications Department, you translate and revise a wide range of texts, including specialized and complex documents related to economy and finance, for a variety of audiences. You contribute to the unit's terminology database and bring your expertise in the provision of linguistic advice Bank-wide. You also provide coaching to more junior colleagues and support the Assistant Director in the day-to-day management of operations.

# Your future responsibilities

You revise and translate texts in all fields – such as technical documents requiring expertise in specialized fields, notably relating to economy and finance – ensuring Translation Services' high quality standards and deadlines are met. You translate some texts independently.

You conduct terminology research to ensure that the vocabulary used in the texts produced is correct and to build the unit's terminology database; you validate the terms proposed by translators or terminologists based on their research.

You provide guidance to more junior colleagues to help them develop their knowledge and skills.

You undertake special translation projects, including some in collaboration with other teams at the Bank and, less frequently, with external partners.

You offer linguistic advice to Bank employees on an ad-hoc basis.

You contribute to the smooth operation of the unit, the recruitment of translators and the performance review of team members. You also provide management support to the Assistant Director.
